# Historian of Montgomery's Alabama Bicentennial Presentation to Annual Meeting Audience

On April 29, 2017, "Historian of Montgomery" Mary Ann Neeley described upcoming bicentennial celebrations of Alabama territorial status and Statehood, with a particular focus on City of Montgomery early history.

Speaking without notes to SMDAL members and guests at the Montgomery Annual Meeting, she noted that Alabama initially was part of a Mississippi Territory. Following the Battle of Horseshoe Bend in the Creek War, a separate Alabama Territory was organized in March 1817, including large, 1817-18 land sales at Milledgeville, Georgia's federal land office, and elsewhere. The City of Montgomery was incorporated on December 3, 1819, and eleven days later, Alabama was founded (Dec. 14, 1819) as the 22nd State in the Union.

In 1817, two Montgomery founding fathers, Andrew Dexter, Jr. from Massachusetts (Ms. Neeley's "favorite founder, but with a life on seamy side") and General John Scott stepping over the line from Georgia, led a speculative rush to buy and sell properties along the Federal Road, with access to Alabama River. Some of that land became Montgomery's New Philadelphia, East Alabama Town, and Commerce Street. The City of Montgomery name honors General Richard Montgomery, who died in the American Revolutionary War attempting to capture Quebec City. Earlier, the County of Montgomery was named for Major Lemuel P. Montgomery, who died at the Battle of Horseshoe Bend.

She recounted the several earlier Alabama capital locations, including Huntsville in the north, where the State was organized, Saint Stephen's to the south, Cahaba chosen by the first Territorial Governor Wm. Wyatt Bibb, and Tuscaloosa to the west – all preceding the final selection of Montgomery as the capital in 1845, despite a later destruction of the Montgomery Capitol building itself by fire on December 14, 1877. Today, the State is installing new landscaping at the Capitol to commemorate 200 years of Alabama history.

Ms. Neeley also commented on the centennial anniversary of the end of World War I, which is being commemorated in Montgomery with a new Maxwell Air Force

Base monument to the airmen of that conflict and with a celebration of the U.S. Army's World War I 42d "Rainbow" Division.

Her closing words to her audience on the importance of history were to "Tell your stories. They will roll their eyes, but they will remember. Keep talking. Tell your stories."

Ms. Neeley spoke of her past Massachusetts visits, particularly praising Plimoth Plantation's reenactor role playing. She was accompanied to the Annual Meeting by her daughter-in-law Mary Alma McClurkin Neeley, also of Montgomery.

#### VI. BOARD OF ASSISTANTS:

#### A. Membership shall consist of:

- 4. Four elected Members at large called Assistants.

#### B. TERM OF OFFICE:

1. The following shall not succeed themselves:

C. **<u>DUTIES OF</u>**: Shall have charge and general direction of the affairs of the Society.

#### D. C. VACANCIES:

#### 1. In the Board of Assistants:

In its own body and of any office may be filled by the Board of Assistants for the unexplored term with the exception of the office of Governor.

2. In the office of Governor:

The Deputy Governor shall immediately succeed to the office and serve the unexpired term, thereby leaving vacant the office of Deputy Governor, the unexpired term of which may be filled by the Board of Assistants.

**E. D. ELECTION:** A majority vote of those present and voting shall constitute an election.

#### F. E. MEETING of Board of Assistants

- 1. Shall be no less than twice a year.
- 2. Shall be at a reasonable date and time prior to the Regular and Annual meetings.
- 3. Notice shall be no less than one week prior to the meeting.

#### VII. ELECTION OF OFFICERS AND ASSISTANTS

#### A. Nominating Committee

- 1. Three Five members will be proposed by the Governor to be approved members will be appointed by the Board of Assistants at the Fall November meeting after the GSMD Congress (or Triennial Meeting).
- 2. Will prepare nominations for all officers for inclusion in the Spring Newsletter.
- 3. Will choose its Chair.

#### B. ELECTIONS:

- 1. Officers and Assistants of this Society shall be elected by ballot **or voice vote** at the Annual meeting.
- 2. Nominations shall be accepted from the floor for any office, with written approval of the nominee.
- 3. A majority vote of the members present and voting shall constitute an election.

#### C. TERM OF OFFICE:

- 1. A term of office is three years or until their successors are elected.
- 2. The officers elected shall take up the duties of their office immediately after the meeting at which they are elected.

#### VIII. DUTIES OF OFFICERS:

#### A. GOVERNOR:

- 1. Shall preside at all meetings of the Society and of the Board of Assistants.
- 2. Shall appoint all committees, (except the nominating committee) authorized by the State and General Societies.
- 3. Shall be ex-officio member of all Colonies, Boards, and Committees except the nominating committee
- 4. Shall approve and sign all contracts and obligations authorized by the State Society or Board of Assistants.
- 5. Shall approve all disbursements.
- 6.Shall perform such duties <u>pertaining</u> as <u>pertain</u> to the chief officer of the organization as are specified in the parliamentary authority adopted by the State Society and in the <u>laws</u> **By-laws** of the General Society. and in these by laws.
- 7.For voting at triennial meeting, see Article VII, Sections 1: a, b, c; 4 of the General Society Constitution and Bylaws.

#### **B. DEPUTY GOVERNOR:**

- 1. Shall exercise all the functions of the office of Governor in case of his (or her) absence or disability.
- 2. Shall be responsible for securing the <u>date</u>, place of meetings, <u>the speaker</u>, and the planning of any meals or refreshments connected with the meetings, the table decorations, etc., and shall notify the membership as to the cost <del>thereof</del>.
- 3. Shall order the past Governor's medal.
- 4. Shall perform other duties as assigned

#### C. SECRETARY:

- 1. Shall keep accurate records of the proceedings of the Society and Board of Assistants meetings.
- 2. Shall keep a correct roll of members as of December 31<sup>st</sup> last preceding, with State and General numbers, names of ancestors and dates of admission.
- 3. Shall be custodian of the seal of the Society, the Charter of the Society <u>and a list of Society property.</u>
- 4. Shall order insignias, emblems and rosettes as members pay for them.
- 5. Shall handle transfers of the Alabama's Society members of good standing.
- 6.Shall transmit annually to the General Secretary on or before February 1<sup>st</sup> a statement giving the total number of Alabama Society members as of December 31<sup>st</sup> last preceding, and any important activities of the Alabama Society during the last Society year.
- 5. 7. Shall transmit to the General Historian the State Society Membership Changes throughout the year of the names of all new members added, Transfers, Name Changes, Deaths, Dropped, Resigned, Reinstated, and Dual memberships.
- 8. Shall transmit to the General Society such additional data as may be desired.
- 9. Shall give due notice to the members of all meetings
- 6. 10. Shall conduct the correspondence of the State Society.
- 11. Shall perform such other duties as the office may require.
- 12. Shall be Chairman of the Membership Committee
- 7. Shall perform other duties as assigned

#### D. TREASURER:

- 1. Shall take charge of all funds belonging to the Society.
- 2. Shall keep suitable books of account.
- 3. Shall charge, collect and receive all fees and dues and all other money payable to the Society.
- 4. Shall invest with approval of the Finance Committee all special funds of the Society in accordance with guidelines for 501(c) (3) status.
- 5. Shall make all necessary disbursements upon the approval of the Governor.
- 6. Shall report the condition of the Treasury at all meetings of the Society and Board of Assistants and to the Governor at any time they or either of them may request.
- 7. Shall report at annual meeting in full of all receipts and disbursements of the preceding fiscal year.
- 7.8. Shall send each member notice of annual dues.
- 8.9. Shall send to the Treasurer General GSMD from the funds of the Society each year the payments required by Article XII, Section 2 of the Constitution and Bylaws of the General Society.
- 9.<del>10.</del> Shall maintain funds of Life Membership dues in a separate account.
- 10.11. Shall, if the Board of Assistants requires it, furnish bond, in excess of the estimated funds in his possession at any time, for the faithful handling of the funds, the premium of such bond to be paid from the funds of the Society.
- 12. The Colony Treasurer may assist in collecting dues and sending them to the State Treasurer.
- 11.<del>13.</del> Shall complete annually an up-to-date list of members in good standing and send a copy to the Historian, Governor, and Secretary, and Year Book Chairman.
- 12.14. Shall complete annually an up-to-date list of each Colony's member in good standing and send it to the Colony Lieutenant Governor <u>along with check for Colony's Per Capita dues</u>. 15. Shall serve on the Year Book Committee.
- 13. Shall timely submit all 501 (c)(3) filings required by the IRS.
- 14. Shall perform other duties as assigned.

#### E. HISTORIAN:

- 1. Shall receive from the Membership Committee the approved Preliminary Application Form.
- 1.2. Shall examine all Worksheets and supplemental papers.
- 2.<del>3.</del> Shall send prepared Application and Supplemental papers to applicants for corrections and signature.
- 3.4. Shall sign and give the date of approval of the applicant-signed lineage papers.
- 4.5. Shall be custodian of all blank lineage papers books, papers, or materials used for the duty of the Historian.

- 5.6. Shall be custodian of all blank Preliminary Application Forms but may disperse said to members and applicants7. Shall be custodian of all completed, approved papers returned by the Historian General for filing.
- 6.8. Shall prepare and certify copies of lineage papers of members desiring to transfer to another State Society.
- 7.9. Shall assign State Numbers to new members.
- 8.10. Shall, on receiving a transferee, notify the Historian General within five days of election, the fact of the transfer, the name and the new State number for the transferee.
- 9.11. Shall issue Passport certificates of membership.
- 10.12. Shall mail new members notice of their election.

## 41st General Congress, by Ann Ferguson, Assistant General

The 41<sup>st</sup> General Congress of the General Society of Mayflower Descendants was held in Plymouth, Massachusetts, at the *Hotel 1620*, September 10-12, 2017. Alabama was represented by five delegates: Alan Davis, Ann Ferguson, Ellie Lienau, Mary Helen Mahan, and Michel Marcoux. Highlights include:

- Three amendments to the constitution were passed.
- An agreement to partner with NEHGS to digitize and index GSMD records was approved.
- A feasibility study on proposed plans for our GSMD campus was approved dependent on raising funds. The first proposed project is to build an annex between the library and the administrative building behind the Mayflower Society House.
- Family Tree is offering a discount to GSMD members for DNA testing. A "Mayflower Society DNA Project" is being compiled.
- GSMD website has information for Junior members, under Education Committee, and a Handbook for Junior chairs under Juniors section.
- GSMD is financially strong. New membership approval is robust but member deaths are resulting in static overall membership.

There was much excitement and information regarding on-going 2020 plans. Highlights include:

- The tentative plan for 2020 Congress includes a week-long agenda of activities in Boston and Provincetown, as well as Plymouth.
- A bronze monument has been commissioned of Governor Bradford to include a perpetually lit candle with his famous "lit candle" quote.
- The sarcophagus has been refurbished.
- It is looking good that we will have a Mayflower U.S. postage stamp. The commemorative coin is more questionable.
- All member societies are requested to donate a minimum of \$5,000 to the \$3 million endowment needed to obtain the National Pilgrim Memorial Meeting House. Grants and corporations will be approached to procure the money needed also.

A new Executive Director has been hired. New GSMD officers were elected (to lead us to 2020!). All names can be found on the GSMD website.

## **Mayflower Family Societies**

Mayflower family societies are run by descendants with a focus on a particular Pilgrim family and their lineage. Many descendants become involved with one or more family societies besides being a GSMD member. As a member of GSMD, you can easily join one of the Family Societies with which we partner, with the Societies requiring some or no lineage information. Dues also vary. *See* the GSMD website (<a href="www.themayflowersociety.org">www.themayflowersociety.org</a>) under the "Our Society" tab at "GSMD Partnerships". Any of the family societies are a great way to meet other "cousins" and friends.

I belong to the Fuller Society, which is designed for those with either Dr. Samuel or Edward as an ancestor. It only requires that you give contact information and pay minimal dues. Their website says that anyone can join. They had their annual meeting right after the General Congress in Hyannis, on Cape Cod. The first night was just a get together and the next day offered the choice between exploring the area or visiting the Sturgis Library in Barnstable, which is the oldest library building there and the original home for the Rev. John Lothrop. His Bible was on display along with pictures of family members. Our guide was most interesting about their history. The Fuller Society banquet was that night and officers for the next three years were installed. The last day we went to Nantucket Island. We took a bus ride around the island and learned much about the place. We were on our own for the rest of the time until we took the ferry back to Hyannis. Then, we said our good-byes as most people were leaving the next morning.

The two and a half days is typical of Fuller Society meetings. In October 2018, the Society meeting will be in Cooperstown, New York, with details to follow in the *Mayflower Quarterly*.



came first layed out 1620" is the only known map of the earliest town layout. The original sketch is bound into the front of a manuscript volume entitled "Plimouths Great Book of Deeds of Lands Enrolled from Ano 1627 to Ano 1651." The first part of the volume is in the handwriting of Governor William Bradford, as is the map. The volume now comprises Vol. 12, Deeds, &c. Vol. 1 1620-1651, Plymouth Colony Records. The sketch shows seven lots, facing "the streete" and bisected by a "high way." The lots are located on what Bradford terms "The south Side" and "The north Side" of "the streete." South side lots below the highway carry the names Peter Brown, John Goodman, Mr. William Brewster. Those above were allocated to John Billington, Mr. Isaak Allerton, Francis Cooke, Edward Winslow. North side lots below the highway bear the names Samuel Fuller, John Howland, Stephen Hopkins, while the land above has the name Gov. Bradford. ## **Message from the Treasurer**

2018 dues are due by December 31, 2017. Please, please, please get them in to me on time! Dues are just \$30 which is quite the bargain among historical societies!

Alabama Mayflower Society dues have always been due by the last day of each year for the following year. We collect dues from our members and submit the General Society (GSMD) and Colony dues to the respective Colony Treasurers. The GSMD has reporting deadlines that each State must meet. These deadlines require that we collect our dues timely. Otherwise, it is very difficult to meet our deadlines and report accurately the number of members for which we owe dues. Many families enjoy a tradition that they are descended from the Pilgrims, which often kindles an interest in finding out more. Sometimes, the stories of a *Mayflower* heritage are true and it is easy to document a descent. More often, the documentation is missing and must be researched and supplied to prove one's line. The good news is that advanced research techniques, improved genealogy library collections, and computerized resources have made the process easier. Within each generation, you must provide proof of the birth, marriage, and death of the line carrier, and the birth and death of the spouse. The best vital records are the birth, marriage, and death certificates for each person. Other documentation might be published genealogies, family documents, and other official records. If you have a relative who is a GSMD member, you may be able to use their lineage documentation to help you with your own documentation research. Also, proof of lineage from the original Pilgrims, through at least the earliest generations, can be found in the GSMD's *Mayflower Families Through Five Generations*, *i.e.*, the "Silver Books." Mayflower Society memberships are handled through individual State societies, including the Society of Mayflower Descendants in the State of Alabama. ## THE SOCIETY OF MAYFLOWER DESCENDANTS IN THE STATE OF ALABAMA Annual Meeting Minutes, April 29, 2017

The Society of Mayflower Descendants in the State of Alabama (SMDAL) met on Saturday, April 29, 2016, at the Wynlakes Golf & Country Club, Montgomery, Alabama.

Governor Ellie Lienau called the meeting to order at 11:06 AM. Elder John Smith gave the Prayer and read the Objects and the Compact. Captain Anne Kilgrow led the Pledge of Allegiance to the U.S. Flag. Governor Lienau called the Roll Call and welcomed new members and guests.

Approval of Minutes: The minutes were approved as published.

#### **Reports of Officers and Committees:**

**Governor - Ellie Lienau:** Ellie attended several Colony meetings and will be going to the General Congress in September.

**Deputy Governor** - **Alan Davis**: Alan welcomed everyone to the Capital Colony and announced speaker Mary Ann Neeley. He asked that everyone let him know in advance if you are planning to attend a meeting so that the SMDAL can make reservations. Also, he said please to remember to sign in and to pay Treasurer Mary Helen Mahan for your meal(s). The next meeting will be in Birmingham at *The Club* on Saturday, October 28, 2017.

## **Colony Activities**

<u>Cahaba River Colony</u>: On May 6, 2017, Ms. Mary Beth Newbill covered considerable Alabama history in interesting fashion for CRC members assembled at the Riverchase Country Club on the Cahaba River in Hoover. She showed slides of Southeast region/Alabama maps that she and others have curated from the Birmingham Public Library's extensive collection. Forming part of the BPL's Alabama Bicentennial Exhibit, the maps are circulating for public viewing (*Alabama's History in Maps*) across the State through the end of 2019. The maps also are accessible online, scanned in high resolution, at <a href="https://www.bplonline.org/almaps">www.bplonline.org/almaps</a>.

Much of the BPL's 16<sup>th</sup>-20<sup>th</sup> century map collection was the 1964 gift of Mr. Rucker Agee, of the former Sterne, Agee & Leach investment firm. Perhaps the collection's most valuable item is the



unique, 11 volume, *Atlas Major*, created and published by the Dutch Blaeu family of printers in Amsterdam. Ms. Newbill commented that when completed, in Latin in 1662, the *Atlas Major* likely was the world's most expensive book. Observing it is "not something people expect a public library to have", the *Atlas Major* may be viewed at the BPL's 2100 Park Place building in Birmingham in a wooden case equipped, she explained, "with rollers, so that in case of fire it will be the first thing out the door." Besides Mr. Agee, other generous contributors to the BPL map collections include John C. Henley III, Dr. Charles Ochs, and Joseph H. Woodward II.

Ms. Newbill structured her historical excursion in four parts: Early Settlement, 1545-1818; Alabama as a State, 1819-1865; Modern Alabama, 1865-Present; and Natural Resources showing Alabama resources and geology, besides agriculture, leading to economic development such as Birmingham steel production, Sylacauga marble, petroleum, natural gas and (!) gold mines. In several striking visuals, after an 1833 map showing Alabama locations for the Cherokees and the Creeks, later maps entirely omitted native American habitats. From the 1830s on, as villages, cities, and counties were forming, such maps were a form of investment "propaganda" assuring prospective land buyers that native Americans were absent. Ms. Newbill will give her talk across the State as part of Alabama's Bicentennial. She observes that "People respond to maps. Maps are an excellent way to tell Alabama's story."

By 1819, the birth and growth of Alabama Territory towns, cities, and communities ensured that the new Territory's population had increased enough to qualify as the minimum Congress required for Statehood. The Alabama Territory became the 22d U.S. State on Dec. 14, 1819. Finally, Mr. Blackmon explained the role of William W. Bibb, who served as Territorial Governor from 1817-1819.
